FOUNDATION STATEMENTS

VISION

Professional excellence in nursing practice, education and research, in a negotiated relationship with Tangata Whenua.

A unified forum for examining issues relevant to nursing and health of the community.

PHILOSOPHY

Nurses are health professionals whose practice is based on a unique body of knowledge.

Nursing knowledge emerges from the collective wisdom of nursing practice. Nursing theory and research underpin the unique body of knowledge that guides and directs nursing education. The knowledge, wisdom and culture of nursing are integral to developing and maintaining professional excellence.

In practising the art of nursing, nurses walk though people's landscapes for varying lengths of time. The spirit, science and art of nursing involve assisting people throughout their lives, and encouraging a sense of individual dignity and cultural wellbeing.

Health is about living in harmony with one's self and the environment. There are personal, spiritual, cultural and collective perceptions of health.

Nurses have a responsibility to negotiate with and advocate for people in their quest for health. This advocacy will be in the social, economic, and political spheres.

INFORMATION SHEET

WHY A COLLEGE OF NURSES?

The College of Nurses, Aotearoa NZ has been established to maintain and promote EXCELLENCE IN NURSING, to encourage research in nursing by nurses and to monitor standards of nursing practice.

The College will not be involved in any industrial or contract bargaining activities. It will provide a combined professional focus for nurses who are currently covered by a range of different industrial bodies. The College aims to bring these nurses into one professional affiliation.

EARLY BEGINNINGS

In August 1991 a group of nurses met in Palmerston North to discuss the feasibility of setting up a College of Nurses. Seven people accepted the responsibility of forming a Project Team to consider the formation of the College, to develop a vision, philosophy, purpose, structure and membership criteria.

As a result of the Project Team's activities, the College of Nurses Aotearoa NZ has become a reality.

The question has been asked why call it a College of Nurses when both Australia and the United Kingdom have a College of Nursing. Nurses are the people who carry out the activities which constitute nursing. We have adopted the policy to name the College after the people involved, in line with the College of Pharmacists and the College of Midwives, etc.

A priority for the project team was to lay the foundation of the College's vision for a negotiated relationship with Tangata Whenua. The rules state that where a decision needs to be made by Council, there will be an equal number of Maori and non-Maori Council members present, or the decision must be unanimous.

A number of Maori have become true leaders in contributing to community health, although nationally, Maori represent a very small part of the nursing profession. A discretionary clause has been included in the membership criteria to enable Maori and non-Maori health workers and enrolled nurses who have shown initiative, leadership and innovation in health promotion and health care to become members of the College.

In keeping with the vision of the College there will be a system of dual patronage: one eminent Maori, Erihapeti Murchie, and one eminent non-Maori, Lady Reeves, both of whom are highly regarded in their community.

CENSORS

Who are these people? The censors are nurses of reknown whose responsibility is to vet all applications for membership and approve those applicants that meet the criteria.

In keeping with the vision of the College, the four nurses who have agreed to be Censors in the initial stages are:

Puti Puti O'Brian, QSM - Patron of National Council of Maori Nurses

Janice Wenn - Service Manager, Manawatu-Wanganui Health Board Yvonne Shadbolt - retired Dean of Health Studies, ATI Nan Kinross - foundation Professor of Nursing Studies, Massey University

REPRESENTATION

It is suggested that the boundary lines of the four Regional Health Authorities be used for the College. One member from each area will be elected by the membership of that area to be their representative on Council. This provides 4 Councillors. In keeping with the vision of the College, there will be a further 4 places for Maori nurses on Council who will be determined by Maori. Three will represent Te Ika a Maui (North Island) and one Te Waka a Maui (South Island).

Nominations for the initial four Maori Council members are invited from iwi, National Maori groups, Maori College members, and the National Council of Maori Nurses. The first four Maori Council members will be determined from these nominations by the Maori Patron of the College, Erihapeti Murchie, in consultation with the two interim censors, Puti Puti O'Brian and Janice Wenn, and the President of the National Council of Maori Nurses.

APPLICATIONS

Applications on the approved form are invited. Send applications to PO Box 31-414 Milford, AUCKLAND, accompanied by an application fee of \$30 and all necessary documentation, as outlined in the Criteria for Membership.

We warmly invite applications from all interested nurses, including those who have retired.

Following acceptance of applications by the censors, membership will be registered on receipt of the membership fee for Members \$80 or Fellows \$100.

All information received from applicants will remain confidential to the censors and the members of the Interim Council.

The Project Team has been Isobel Hawley, Laura Hawken, Carol Peterson, Roseann Englefield, Irihapeti Ramsden, Mike Maddison, Pauline Hill.

For administrative purposes these same people will be the Interim Council until the Annual General Meeting to be held on 18-19 September 1992.

It should be noted by all potential members that those on the Interim Council will apply for membership in the stated manner and will play no part in determining College membership.
